# 3.1 Approval of August 30, 2017, meeting minutes

MOTION: Stiles/McPherson to approve the minutes of the August 30, 2017, Santa Margarita Groundwater Agency (SMGWA) Board of Directors meeting. Motion carried by a voice vote of nine to zero with one abstention (Engfer).

#### 4. General Business

# 4.1 Santa Margarita Groundwater Agency Principal Office and Business Agent

MOTION: McPherson/Stiles to establish Scotts Valley Water District as the principal office and the business agent, San Lorenzo Valley Water District as the alternate business agent, designate the General Manager of Scotts Valley Water District as the staff representative of SMGWA and the District Manager of San Lorenzo Valley Water District as the alternate staff representative. Motion passed by unanimous voice vote.

# 4.2 <u>General Legal Counsel Contract</u>

ACTION: Correct the last paragraph of the staff report to indicate that staff is recommending executing a contract with a term through the end of the fiscal year 2018, not 2020.

Public comment made by Terry Rein.

MOTION: Ratcliffe/McPherson to approve and authorize staff to execute a contract with Rein & Rein, Santa Cruz, CA for general legal counsel services. Motion passed by unanimous voice vote.

# 4.3 <u>Santa Margarita Groundwater Agency Bylaws</u>

Suggested changes to the Bylaws were discussed by the Board.

ACTION: Update 1.2 to read, "PRINCIPAL Office AND BUSINESS AGENT. The principal

office and the business agent of the Agency shall be at the Scotts Valley Water District located at 2 Civic Center Drive, Scotts Valley, CA 95066, or at an alternate location as the Board may designate by resolution. Business agent shall provide administrative services pursuant to an administrative

services agreement with the Agency."

ACTION: Section 2.3 should be 2.4.

ACTION: Add "2.5 Director Compensation. Directors and members of committees

shall serve without compensation from the Agency. Each Director or committee member may be reimbursed his or her necessary and actual expenses, including travel incident to services as a Director or committee member, as may be determined by the Board to be just and reasonable. Any Director or committee member may elect, however, to decline said

reimbursement."

ACTION: Add the following to 3.3, "Any Director may require that an item be placed

on the agenda for any regular meeting of the Board by submitting a written request to the Agency Board Chair and Vice Chair 30 calendar days before the meeting. Said Director must notify all Board members and executive and

administrative staff."

ACTION: Article 4 should be titled Powers.

ACTION: Remove the word make from the last sentence in section 5.1.

ACTION: Add the following to 6.1.3, "Designated administrative support staff may be

required to support the Agency. The Agency shall budget and reimburse Member Agencies for the salary and benefit costs of designated staff subject

to review and approval by the Board."

ACTION: Staff should capitalize all Member Agencies in bylaws.

ACTION: Add Appendix A to the header on Appendix A.

ACTION: Correct numbering in section 9.3

ACTION: Board members will send minor edits to administrative support staff. Staff will

edit Bylaws and share with Board members for further editing.

4.4 ACWA Membership

MOTION: Stiles/Baughman to direct staff to process necessary steps for SMGWA joining Association of California Water Agencies (ACWA). Motion passed by unanimous voice vote.

# 4.5 Groundwater Sustainability Planning Grant Application

MOTION: McPherson/Dilles to adopt Resolution No. 2017-01 authorizing staff to submit an application and execute an agreement with the Department of Water Resources for the 2017 Sustainable Groundwater Planning Grant. Motion carried by unanimous roll call vote.

## 5. Staff Reports

Sierra Ryan reported that if awarded the Groundwater Sustainability Planning Grant, the Agency may want to consider facilitation services to help develop the process by which we move forward with development of the plan.

Rosemary Menard reported that the Mid-County Groundwater Agency has been hosting groundwater orientation sessions for the public. The first session was recorded and is available on the <u>Mid-County Groundwater Agency website</u>. The next sessions will be on November 13, 2017, and December 7, 2017.
